- 3). All of our services are absolutely free. We never charge insurance companies, the city or the county any money.

PINWHEELS FAMILY FUN DAY: BIGGER & BETTER







Nearly 400 children, families, community partner agencies and youth performers attended our ninth annual Pinwheels Family Fun Day on Sept. 21 at Cole Park Amphitheater.

Guests enjoyed entertainment, free food, community resources and giveaways – and even visits from the Corpus Christi Fire Department and superheroes! A total of 1,667 pinwheels were displayed, representing the number of children who were forensically-interviewed at the Center due to allegations of abuse in 2018.

Our list of performers included Moody High School Cheerleaders and TJ Strutters; Carroll High School Tigerettes; Ray Tex-Anns Dance Team; Kaymoni Guerrero; Cinderella School of Dance; Ballet Folklorico Viva Mexico de Corpus Christi; and Matt Rodd.

We had around 25 community agencies participate (more than double from last year) inclding CASA of the Coastal Bend, the United Way's Success by 6 Program, the Purple Door, Corpus Christi Police Department Crime Prevention Unit, the Texas Department of Family and Protective Services and more. Thanks to our participants and several volunteer groups (Moody Key Club, the Corpus Christi Police Explorers, TJ Maxx) and many other volunteers.

children, some of whom aren't even old enough to speak.

5). We're often the first place where the child is able to freely discuss the full scope of the abuse that has occurred and where they can begin their healing.

This year, 25 local funders have pledged \$950,000 in matching grants. Any amount over \$10 donated will be matched and doubled, so we can raise at least \$38,000.

EXECUTIVE DIRECTOR'S CORNER

Did you know that nearly half of all U.S. children have endured some form of childhood trauma? According to the National Child Traumatic Stress Network, with evidence-based treatment, like Trauma-Focused Cognitive Behavioral Therapy, trauma symptoms can be reduced by up to 75 percent.

The Children's Advocacy Center of the Coastal Bend focuses on the healing process for children after they've experienced abuse by utilizing trauma informed care. Just as all services at the CACCB. therapy is provided at no cost. In the Center's most recent quarter (July - September 2019), we provided more than 80 on-site mental health sessions to children who were victims of abuse and their nonoffending family members. Research has shown that children who experience abuse, neglect, family violence, or endangerment experience higher levels of depression, anxiety, substance abuse, and suicide. A positive event in the healing process, such as providing a safe place to offer trauma informed care, can act as a motivating factor and beacon of light for child abuse survivors and is life changing.



PARTNER PROFILE: MARGIE SILVA FLORES

Assistant District Attorney Margie Silva Flores believes that the strength of a community is measured by how it treats its most vulnerable of victims, children.

"The voice of every child matters," said Flores, who has worked with the CACCB for the past three years as the prosecutor who handles Family Violence, Sex Crimes and all crimes against children cases, in the 79th Judicial District Attorney's Office (Jim Wells and Brooks counties). She said that the CACCB provides invaluable resources for small jurisdictions with limited resources for training and a limited number of officers.

"The expertise of the Children's Advocacy Center



forensic interviewers is crucial for Child Sexual Abuse cases," she said. "In trials, the expert knowledge of the forensic interviewer is vital for the jury, as it helps a jury understand children and how the outcry process of a child's sexual abuse unfolds."

In addition to interviewing

children, Flores said the CACCB provides aftercare services for children and their family, such as counseling.

"Counseling is absolutely necessary for a child to overcome the trauma and scars of sexual abuse," she said. "It is an experience that they will live with for the rest of their lives. The strength and courage that it takes for a child to tell their story of abuse initially and then one final time to a jury, while their abuser watches, is unimaginable. The (children) are true heroes."

Flores said the CACCB staff always goes the extra mile for children. She is thankful for the open communication between her offices and the Multi-Disciplinary Team to solidify a strong case for trial.

"There is no greater endeavor than fighting for the justice of a child victim," she said.

ART FROM THE HEART: KILEY LOCHNER CREATES PAINTINGS FOR THE CACCB



In August, we received 18 colorful canvases created to display at the CACCB by Kiley Lochner. This was part of her 50-hour Girl Scouts Silver Award Project, which she started in January and completed in July.

Lochner, 14, wanted her project to focus on abused children, and after doing some research, she found the Center.

"I wanted to lift heir spirits and make sure they know that others pay attention to them," said Lochner. "I wanted to create something bright and happy for them."

STEWART TITLE DONATES BACKPACKS


